- Receive, or have received, free school meals, Pupil Premium, Education Maintenance Allowance, and/or 16 to 19 Bursary.
- Be, or have been, a full-time or part-time carer.
- Have come to the UK as a refugee or asylum seeker.
- Have a main household earner in a routine or manual occupation.
- Attend a school with below average Higher point scores and/or low progression to higher education.
- Grew up in a household where no parent or guardian attended university.

Please note - students meeting the 'in local authority care' criterion do not need to meet any other criteria
